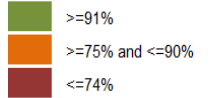

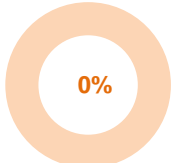

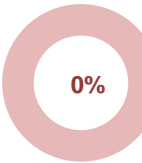

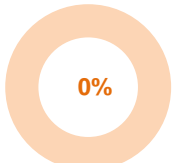

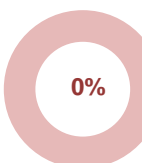

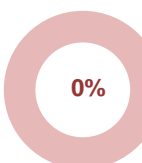

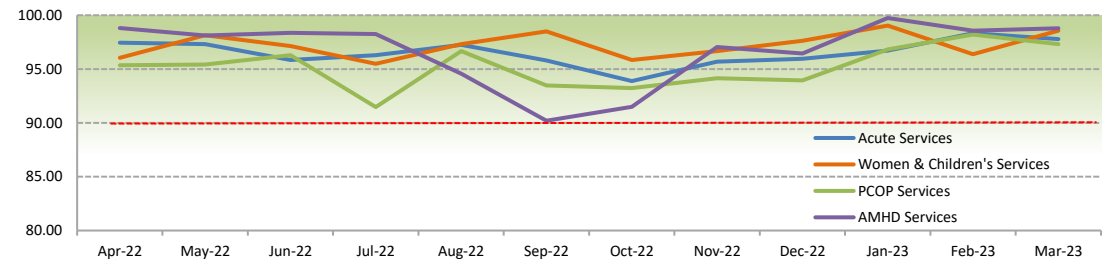
## Bi-Monthly Audit Compliance of 39 Areas



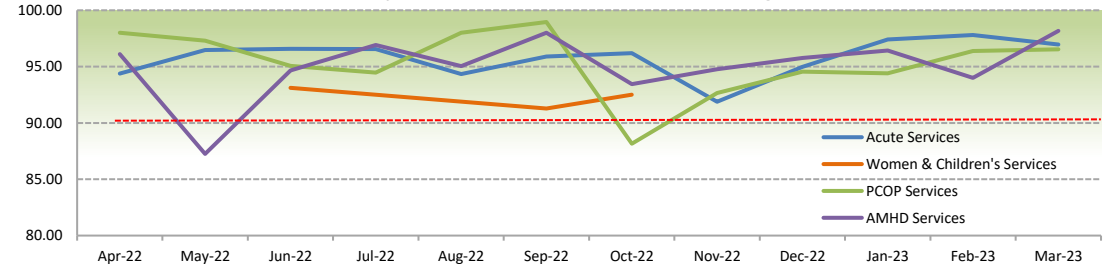
