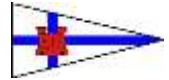

‘L.E.Y.C. Sailability’ 2022 is starting. We plan to hold weekly sessions on a Tuesday and on Most Saturday’s, starting on Tuesday 3rd May, hopefully continuing until the end of September.

We can accept up to eight people per session, aiming to offer a minimum of half an hour on the water sailing. (Weather permitting.) We may cancel sessions by email, the evening before, if unsuitable weather is forecast.

Hoist:

LEYC have the facility to hoist participants into the sailing boats. (We only have 1 sling.)
Please note, participants requiring hoisting into a boat should bring their own 'sling', when applicable. Carers will be responsible for 'fitting' the sling and assisting LEYC volunteers operating the hoist.
