2023/24 : Overview

The Plan is based around three regional high impact areas:

- Maximising ambulance capacity
- •Reducing time spent by patients in emergency departments awaiting clinical decision and next stage of care
- •Timely hospital discharge for patients who are medically fit for discharge.

The Plan also sets out the key enablers to help us deliver, including our staff health and wellbeing, surge / industrial action preparations and comprehensive local and regional oversight arrangements.





Regional Priorities

Maximise Ambulance Capacity

- Work with NIAS to support ambulance handover, enhanced coordination and smoother patient transfer
- Maximise ambulatory pathways to reduce need for ED attendance and admissions
- More effective use of community services / pathways to maintain people safely at home
- Weekly rapid access frailty clinics at both hospitals.

Reduce Time Spent in ED

- Implement Minor Injuries Unit at Altnagelvin Hospital
- Consolidate acute hospital site coordination hubs to manage patient flow
- Mental Health Liaison team support for patients in ED where required
- Implement agreed ED staffing resilience plan.

Timely Hospital Discharge

- Coordinated approach to patient discharge including best use of discharge lounge
- Enhanced independent sector care home oversight arrangements
- Enhance access to intermediate care beds and EMI placements
- Maximise Domiciliary Care provision
- AHP focus on supporting discharge and hospital flow.

Protect Elective Capacity

- Focus on meeting HSC Service Delivery Plan targets and associated recovery plans
- Explore hospital capacity and capability to maintain elective inpatient services
- Build on dedicated elective day care & overnight stay models at Omagh & South West Acute Hospitals
- Maximise theatre capacity
- · Maximise available funding for waiting list activity making full use of independent sector providers
- Continued regional clinical prioritisation to ensure equity of access to elective capacity.

Protect Staff Health & Wellbeing

- Occupational health targeted sickness absence support
- Trust health and well being programmes
- Ongoing senior management visibility
- Timely recruitment to mimimise vacancies
- Improve uptake of flu and COVID vaccines.

Surge Preparation

- Implement Trust Surge plans & business continuity arrangements including flexible staff working and Infection Prevention & Control measures
- Implement COVID-19 boster / vaccination programme.

Industrial Action Preparation

- Enhanced command & control arrangements / Industrial Action Working Group in place
- Updated business continuity plans and action cards
- Ongoing engagement with Trades Unions
- Communication with staff, public and key stakeholders.

Monitoring & Reporting

Regional Priorities

- Enhanced monitoring and oversight at all levels
- Support implementation of escalation process and service continuity plans
- Work with Regional Coordination Centre to minimise disruption to patients.

Access to theatre sessions:

In the Southern Sector Gynae are using 73% of funded sessions with a plan to be at 100% by end of November with new Consultants:

- SWAH 5 sessions out of 6
- Omagh 3 sessions out of 5

It is anticipated that WHSCT will be in a position to offer the full complement of sessions in Southern Sector by November 2023.

- **Colposcopy**, with the appointment of the new Consultant in October to SWAH, WHSCT is now able to get Colposcopy re-established in SWAH from the start of November, validation work has started.

Rebuild trajectory for 19.5 commissioned sessions

SWAH sessions are up by 59 on the same period 22/23, Utilisation has dropped slightly however this has coincided with the reintroduction of PAEDS Dentals and Day Case Breast sessions.

SWAH EOSC is funded for 19.5 weekly sessions (10 IP and 9 DC sessions per week, plus 0.5 MRI session weekly). Coming into 2023 SWAH only had capacity to run 2 sessions per week which was used for red flag General Surgery or Gynae patients. As of September 2023 WHSCT is in a position to deliver 11 to 12 sessions per week. Based on current staffing projections the trajectory to fully funded level

FODC Health & Social Care Committee



- WHSCT has introduced 2 Breast sessions (fortnightly) providing a new service within the Southern Sector which previously would have only been available in the Northern Sector.
- SWAH is delivering 5 Gynae sessions per week up from 0 sessions in January of 2023 and brought stability back to the service.
- Elective General Surgery has been significantly enhanced despite the temporary change in SWAH General Surgery.
- Paediatric surgery has resumed with plans to add further sessions as WHSCT continues to rebuild toward funded levels. On 23rd October SWAH will run both Gynae and PAEDS sessions concurrently.
